- use their extensive practice experience to plan and provide skilled and competent care to meet patients' health and social care needs, involving other members of the wider health care team as appropriate; to include working with the care home team and patients to provide advanced care plans for patients;
- ensure the provision of continuity of care including follow-up visits;
- assess and evaluate, with patients, the effectiveness of the treatment and care provided and make changes as needed;
- work independently and as part of a local and wider health care team;
- provide leadership; and clinical support to other team members, make sure that each patient's treatment and care is based on best practice
